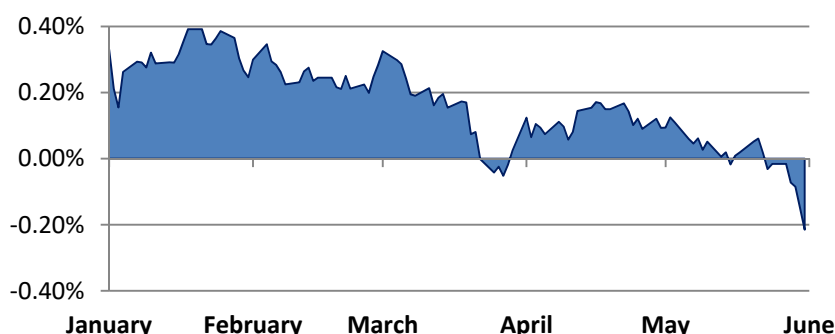


# LCG Market Update / May 2019

ASSOCIATES

- The yield on the U.S. 10-Year Treasury fell from 2.52% to 2.12% during the month of May.
- Renewed fears of a trade war with China along with proposed tariffs on Mexican exports to the U.S. drove yields lower during the last week of the month.

## Three-Month / Ten-Year Treasury Yield Differential



At the end of May, the inversion of the 3-month and 10-year yields expanded to 21 basis points. As of the beginning of June, the implied probability for a Fed Funds rate cut during 2019 was 97.6% as measured by the futures market. The probability of at least 2 cuts before the end of October was 62.5%. In spite of these odds, the second estimate of Q1 GDP came in at 3.1% during the last week of May.
