



- Domestic Equities were positive last week (S&P 500 +1.9%) due to optimistic economic data and talk of another round of stimulus via a \$1 trillion infrastructure deal.
- The Commerce Department reported a 17.7% month-over-month gain in retail sales for May – the largest monthly increase ever.
- The Fed announced that they had expanded their bond-buying program to include corporate bonds. The broadened scope will allow the credit facility to make more precise cash injections into the lending market than were previously permitted.

Figure 1. Index Performance

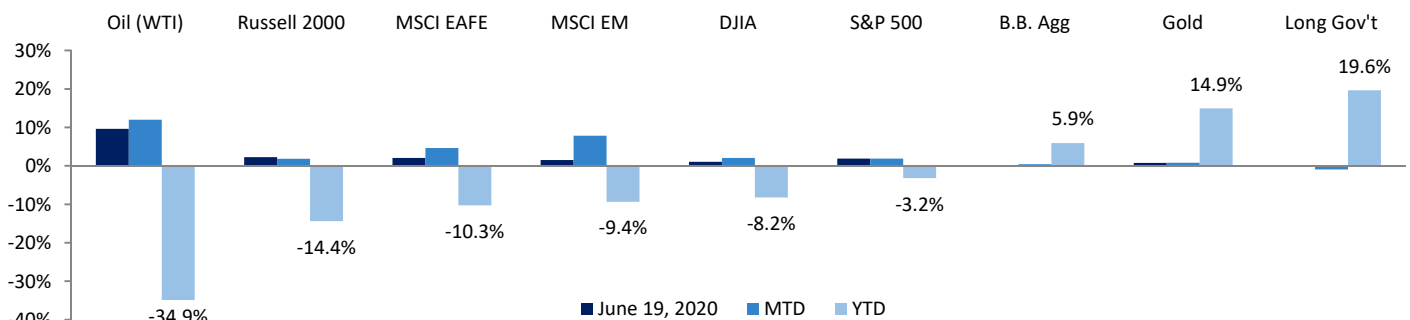


Figure 2. S&P 500 Sector Performance

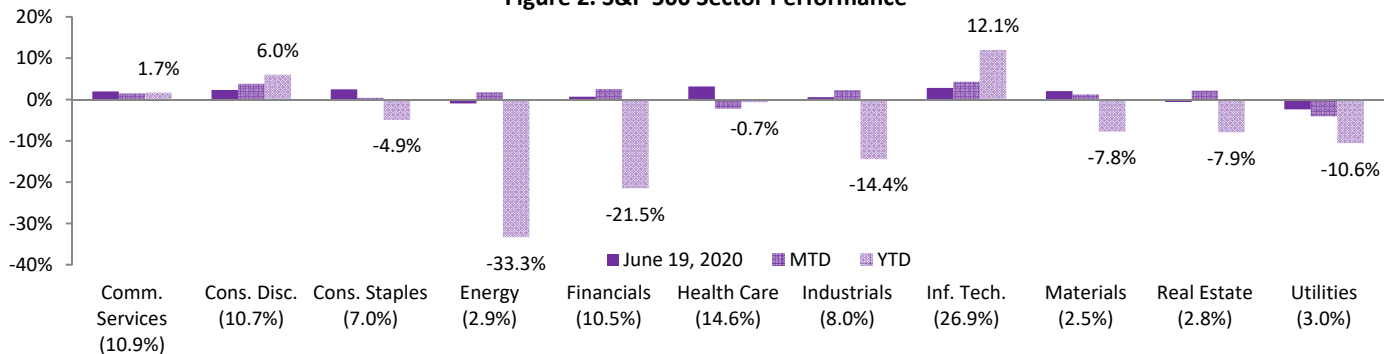
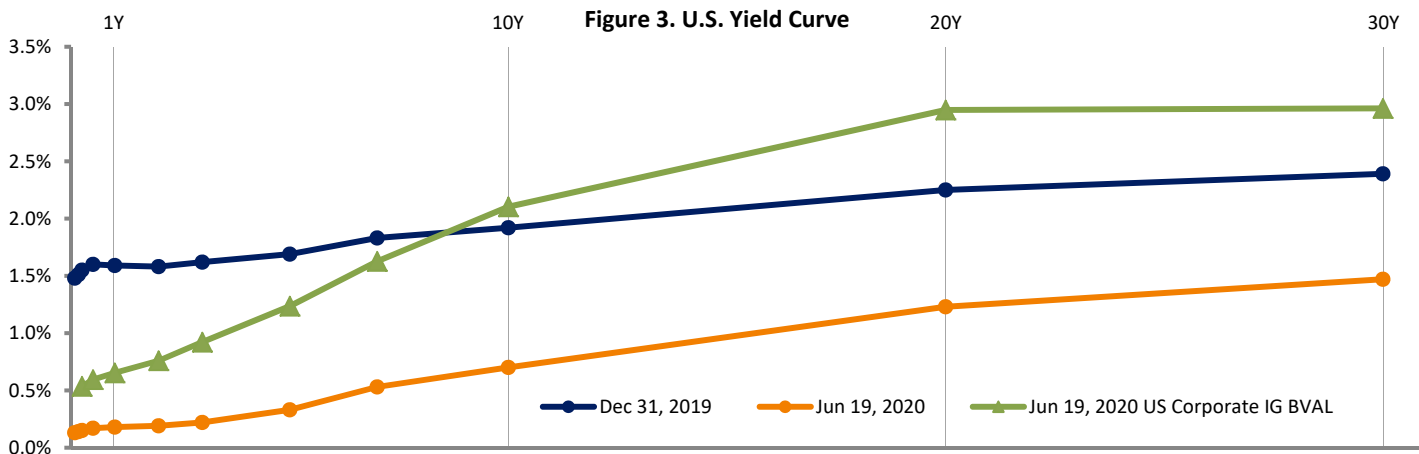


Figure 3. U.S. Yield Curve
